Refund Policy – to be paid based on Refund Policy per Resident Agreement:

Plan A – Minimum 50% refunded. Frederick earns 2% for each month of occupancy up to a maximum of 50% of the entrance fee.

Plan B – Declining refund. Entrance fee refund is reduced by 2% for each month of occupancy for fifty months.

Plan C - Minimum 90% refunded. Frederick earns 2% per month for first five months. After 5th month, 90% will be refunded.

Meal Plan A includes a meal allowance of \$150 per person per month. Meal Plan B includes a meal allowance of \$300 per person per month.

Additional fees will be assessed for finished second floors, covered porches, screened in porches, four season rooms, and two car garages.
